Dexis Consulting Group requests quotations for the provision of IT Equipment (info-kiosks) for the Ungheni and Balti District Courts, Republic of Moldova.

BACKGROUND

Dexis Consulting Group (Dexis), an international consulting company based in Washington D.C., USA, is currently implementing the USAID-funded **Model Court Initiative Project in Moldova (MCI)**. The goal of the MCI project is to assist the Government of Moldova to implement initiatives aimed at improving the efficiency, performance, and quality of court services based on best international practices and in line with international excellence standards for court services.

INSTRUCTIONS TO OFFERORS

With this RFQ, Dexis is soliciting offers from qualified companies to participate in the tender for delivering IT equipment for the Ungheni and Balti District Courts in accordance with the specifications set forth below. As part of project activities, the MCI in Moldova requires the purchase of IT equipment for Ungheni and Balti District Courts' needs. The purpose of this RFQ is to solicit quotations for these items.

Offerors are responsible for ensuring that their offers are received by Dexis in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere to the instructions described in this RFQ may lead to disqualification of an offer from consideration.

Offer Submission Deadline

Offers must be received no later than **August 31, 2021, 17:00 local time**. Proposals received after the deadline may not be considered.

Submission of Offers

All offers must be submitted electronically to the following email address: moldova@dexisonline.com. Offers must be on company letterhead with the company's contact name and address.

Please quote reference "RFQ # 2004-06" in the subject of the email.

Questions and Clarifications

All questions and clarifications regarding this RFQ must be submitted in writing to moldova@dexisonline.com no later than **August 26, 2021, 17:00 local time**. All correspondence must provide reference to the RFQ number. Questions and clarifications that may be of interest to other bidders, will be circulated to all parties that submitted the questions.

Only the written answers issued by Dexis will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of Dexis or any other entity should not be considered as an official response to any questions regarding this RFQ.

Required Documentation

The offers must include the following:

- Cover letter, signed by an authorized representative of the offeror, which contains general information about the contractor, including full legal name and address of the company, full name of the legal representative

(president or managing director) of the company, a contact name, email address, and telephone number to facilitate communication between Dexis and the prospective contractor (see below [Annex A](#) for template);

- Official quotation, including specifications of offered equipment (see Section **TECHNICAL REQUIREMENTS** for example format). Offerors are requested to provide quotations on their official letterhead as per format described in the Section **TECHNICAL REQUIREMENT**, by completing the table provided herein;

- One page summary of the offeror's capabilities to supply the required Items, indicating brief history of the company, demonstrating at least 3 years of previous experience in selling and distribution of computers and IT equipment on the Moldovan market;

- Copy of offeror's corporate and tax registration documents or business license;

- Minimum of three (3) references of the similar work performed in the past three (3) years. References must include the following: name of the entity; contact name, phone number and email address; time periods when the work was performed; brief description of tasks, responsibilities, and deliverables.

- If asked by Dexis, the Offeror shall provide the names and contact information for three references that Dexis may contact for an assessment of your company's past performance.

Offerors are requested to provide quotations on their official quotation format or letterhead.

Source/Nationality / Origin

All goods and services offered must be in Moldova at the time of purchase. Only firms legally registered in Moldova may submit an offer in response to this RFQ.

All goods and services offered in response to this RFQ or supplied under any resulting award must meet **USAID Geographic Code 937** and **110** in accordance with the United States Code of Federal Regulations (CFR), [22 CFR §228](#). The cooperating country for this RFQ is Moldova.

Offerors may not offer or supply any commodities or services that are manufactured or assembled in, shipped from, transported through, or otherwise involving any of the following countries: Cuba, Iraq, Iran, Laos, Libya, North Korea, and Syria.

Quotations

A. Cost: Prices must be quoted as showing unit prices and total prices with VAT 0% and inclusive of VAT. Offers must clearly list all the goods and services, indicate unit prices, quantities and total price.

B. Specifications: The below section "**TECHNICAL REQUIREMENTS**" contains the technical specifications of the required items. All commodities offered in response to this RFQ must be new and unused. In addition, all electrical commodities must operate on 220V, 50Hz.

C. Brand Names: Please note that, unless otherwise indicated, stated brand names or models are for illustrative description only. An equivalent substitute, as determined by the specifications, is acceptable.

D. Warranty: Full warranty service and repair within the cooperating country is required for all commodities under this RFQ. At the time that any commodity is transferred to another entity within the cooperating country, all rights to warranty support and service shall be transferred with the commodity to that entity's end-user.

E. Delivery: The delivery location for the items described in this RFQ is mentioned in "**TECHNICAL REQUIREMENTS**" (the exact address will be specified in the contract or purchase order). As part of its response to this RFQ, each offeror is expected to provide an estimate (in calendar days) of the delivery timeframe (after receipt of order). The delivery estimate presented in an offer in response to this RFQ must be upheld in the performance of any resulting contract.

F. After-sale service: The ability to provide timely and complete after-sale service at an authorized center.

Validity Period

Offers must be valid for a minimum of sixty (60) calendar days after the offer deadline.

Eligibility: By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Dexis will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.

No item originating or sourced from Cuba, Iraq, Iran, Laos, Libya, North Korea, and Syria and below companies will be allowed:

- Huawei Technologies Company;
- ZTE Corporation;
- Hytera Communications Corporation;
- Hangzhou Hikvision Digital Technology Company;

- Kaspersky Lab.

Negotiations

It is expected that awards will be made based on submitted offers. However, Dexis reserves the right to conduct negotiations and request clarifications prior to awarding the contract.

Basis for Award

The award will be made to an offeror whose offer is compliant with RFQ instructions and is evaluated as the most advantageous for Dexis.

Terms and Conditions

The award is subject to Dexis's standard terms and conditions. Please note that Dexis standard payment terms are ten (10) banking business days upon receipt of the complete documentation after acceptance of the deliverables. No advance payments are possible.
